a. Policy Consent

Board Policy 3035 – Investment of District Funds

Manager Caccavo reported that the current policy restricted our investment options; this revised policy open to those beyond LAIF & CalTRUST. Staff is looking into additional investment opportunities.

8. Oral Report

a. Fire Chief

Fire Chief McQuead reported on 9/6 the Elfin Forest/Harmony Grove (EF/HG) had their Fire Safe Council approved. On 9/8 had a town hall meeting at Station 5 with EF/HG, called the Wildland Preparedness, 60 residents showed up. On 9/16 hired Battalion Chief Greg O'Gorman coming from Alpine Fire. Issued first Citation to a resident who was installing speed bumps on their own which damages the engine and ambulance. The District was invited to the RSF Association for town hall on 10/25/2022.

b. Operations

Deputy Chief Slattery reported that the District is fully staffed. Battalion Chief Luke Bennett has been moved to Training and the four new Firefighter/Paramedic recruits started on the floor on 9/3. Down to 5 reserves currently with a plan to capture the graduates from Palomar and Miramar Colleges in December. Ian O'Connor and Justin Cloyd were promoted to Engineer rank on 9/1.
