

RANCHO SANTA FE FIRE PROTECTION DISTRICT REGULAR BOARD OF DIRECTORS MEETING MINUTES – January 9, 2008

A regular meeting of the Rancho Santa Fe Fire Protection District Board of Directors was called to order at 1:00 p.m.

5. Old Business

a. Acceptance of Donations

Chief Pavone distributed an updated list of residents who sent a check in gratitude of the efforts and performance of District personnel during the October 2007 wildfires. To date, unrestricted cash donations total \$41,100. A donation for \$2,500 was received with a specific request to purchase goggles. This purchase is currently being researched. He also reminded the Board that the District sends letters of acknowledgement to the donor.

Chief Pavone reported to the Board the outcome for each employee group's vote regarding the employees' proportionate share. The members of the Firefighters Association requested that the final per person contribution be remitted to the Professional Firefighters Association and that the Administrative/Prevention personnel and the Management personnel selected a one-time distribution to their Health Retirement Savings account.

Accept the monetary donations totaling \$13,000 because of the October 2007 wildfires and distribute the proportionate share as approved at the December 2007 Board of Directors meeting. (Note: Total received through January 9, 2008 - \$43,600)

6. New Business

a. Contract: Duty Coverage between Rancho Santa Fe Fire Protection District and Solana Beach and Del Mar Fire Departments.

Chief Pavone summarized the staff report included. He reminded the Board members that the District gave notice in August 2007 to terminate the existing duty-coverage contract. The current contract does not include any compensation for services since the District agreed to an "in-kind" contribution during the cooperative efforts evaluation.

Chief Pavone reported that although the evaluation is complete, there is a desire by the City of Solana Beach to continue duty coverage by contract. He estimated that the Battalion Chiefs spend approximately 15 hours per month responding to the cities of Del Mar and Solana Beach Fire Departments. The proposed agreement is the same with the exception of a compensation clause, and that the contract was prepared originally by the District's legal counsel.

MOTION BY DIRECTOR MALIN, SECOND BY DIRECTOR TANNER, CARRIED 3 AYES; 0 NOES; 2 ABSENT; 0 ABSTAIN to approve the contract for duty coverage between Rancho Santa Fe Fire Protection District and Solana Beach and Del Mar Fire Departments.

b. Contract: Recognition of New Classification and Salary Range of Office Support Coordinator Chief Pavone reported that when the Staff Assistant for Fire Prevention resigned her position in August 2007, the managers reviewed the position description and re-titled the classification, not realizing the Memorandum of Understanding (MOU) did not cover that classification. The incumbent in the Office Support Coordinator position has requested that her position be recognized and added as a represented classification for wages and benefits. The salary range is set at the same pay range as Staff Assistant I.

MOTION BY DIRECTOR MALIN, SECOND BY DIRECTOR TANNER, CARRIED 3 AYES; 0 NOES; 2 ABSENT; 0 ABSTAIN to approve the following:

- 1. Add a new classification title Office Support Coordinator;
- 2. Set the pay range for Office Support Coordinator at the same pay range as Staff Assistant I;
- 3. Establish a side letter between Rancho Santa Fe Fire Protection District and Rancho Santa Fe Fire Protection District Employees Association in recognition of the new classification; and
- 4. Authorize representatives of Rancho Santa Fe Fire Protection District to execute the side letter effective January 9, 2008.
