JUSTIFICATION for Funding Request:

At a regular meeting held February 11, 2009, the Board of Directors authorized \$2,500 expenditure to participate in a cost analysis for a parking structure on property owned by The Inn at Rancho Santa Fe. Since that meeting, additional consulting costs were identified such as a necessary soils and engineering costs to determine the feasibility of constructing a parking structure. The range listed is the District's proportionate share of participating in the cost analysis that will provide needed information so that all participants will have an accurate budget for determination of their pro rata participation in the project.
