





Bicyclist hurt in crash with SUV

NORTH COUNTY — A bicyclist and a motorist were injured Monday after the 17-year-old driver of an SUV lost control of her vehicle and rolled it several times, striking the 29-year-old bicyclist in the process, authorities said.

The crash was reported around 3:14 p.m. near the intersection of Camino del Norte and Dove Canyon Road in 4S Ranch.

Firefighters from the Rancho Santa Fe Fire Protection District responded to the accident and transported the girl and the woman to the hospital for evaluation. The extent of their injuries wasn't released.



RANCHO BERNARDO: Crash injures bicyclist, motorist

RANCHO BERNARDO ---- Two people were injured in a crash between an SUV and a bicycle Monday afternoon, according to authorities.

The crash occurred when a 17-year-old girl lost control of the SUV she was driving and rolled it several times, hitting a bicyclist in the process, said Julie Taber, a spokeswoman for the Rancho Santa Fe Fire Protection District.

The crash happened at the intersection of Camino del Norte and Dover Canyon Road in 4S Ranch shortly after 3 p.m., she said.

The driver of the SUV and the 29-year-old woman on the bicycle were taken to Palomar Medical Center for treatment. No details on the extent of their injuries were immediately available.

Small fires within district reinforce need for awareness, fire experts say

The occurrence of several small fires within the Rancho Santa Fe Fire Protection District within the last couple of months has fire officials asking for the public's diligence when it comes to fire prevention. While the fires do not all appear to be related, they do serve as a reminder that attentiveness is important during fire season.

The first two incidents were grass fires. One happened on May 24, burning 1.5 acres near Lake Drive and Ash Lane in the Del Dios area while the other occurred on June 29 in a vacant lot along Artesian Road, just outside the community of 4S Ranch, and burned 2.2 acres. The third fire, which took place on July 1, charred a small area of vegetation along the 9700 block of Del Dios

Highway. The most recent incident, which involved an outbuilding near Albert Avenue and Camino San Thomas in 4S Ranch, happened on July 14. None of the incidents resulted in any injuries.

"Fortunately, these fires were all reported quickly, allowing our firefighters to extinguish them before they got out of hand," said Fire Chief Nick Pavone. "Following these incidents we are asking the community to help us in two ways. First, create defensible space by clearing all dead and dying brush away from your home. Second, keep an eye out and report any suspicious behavior by calling 9-1-1."

Reducing greenhouse gases a focus of new transportation plan

Getting from Point A to Point B in a more environmentally friendly way is a focus of the 2050 Regional Transportation Plan the San Diego Association of Governments (SANDAG) is developing for the region.

"We are planning to meet this region's needs for transportation, housing, and open spaces in a way that reduces greenhouse gases and protects the economy," SANDAG Executive Director Gary Gallegos said.

SANDAG is the first Metropolitan Planning Organization (MPO) to develop a Regional Transportation Plan (RTP) under new state legislation that requires cities and counties to coordinate development patterns and the transportation network, policies, and programs to reduce greenhouse gas (GHG) emissions from cars and light trucks.

These GHG reduction targets for the San Diego region (and other California regions) will be established by the California Air Resources Board (CARB). SANDAG has been working with



Month was coolest July in nearly a century

By City News Service The average high temperature for July at Lindbergh Field — San Diego's official reporting station - was the lowest in nearly 100 years, the National Weather Service

The average daily maximum was 69.4 degrees, the fifth lowest on record and the coolest since 1916, according to the NWS.

The overall average reading, with the daily high and low temperatures combined, was 65.9 degrees, the 14th lowest on record. That's despite a four-day, mid-month heat wave in which highs soared into the 80s downtown and high 90s in most inland

In various locations around San Diego County last month, records for low maximum temperatures were set on 21 days.

Change is not forthcoming now that it is August, NWS meteorologist Noel Isla said.

"For the coast, where the San Diego record is, we're not looking for any immediate warmup," Isla said. "It looks like the forecast for the next seven days is for night and morning low clouds and partial clearing in the afternoon."

He said the inland valleys and mountains could have temperature increases of a couple degrees this week.

"Nothing really is significantly changing," Isla said.

The normal high temperature at Lindbergh Field in July is 75.8 degrees. Ramona, normally one of the warmer inland communities, had an average daily high of 84.8 degrees last month, compared to a normal of 89.9 degrees.

The NWS blamed a low pressure system along the West Coast for most of the month.

Dill has been with the district for nine years and has served as the loss control analyst, director of risk management and executive director of business services.

Dill said he is fortunate to be working with such a great staff.

"I know all our problems are external with budget cuts and the economy," Dill said. "Our problems are not internal, making my move into my new role much easi-

Dill has lived in San Diego for more

than 20 years, moving here to attend San Diego State University. His background is in risk management—he started in the field at Magic Mountain. Before coming to the district he worked for Poway Disguise Inc., a Halloween costume company,

Coming to SDUHSD was like coming full circle, he said, as his original plan in college was to become a teacher.

"It allowed me to get back into education," Dill said. "It's very rewarding. While I'm not in the classroom, the work I'm doing supports learning."

As the director of business services, Dill looked after financial purchases and handled risk and nutrition services. The new post will tack on duties related to facilities and transportation. He will continue to work through the budget crisis, which he was already doing, just at a higher level.

"We're not out of the woods yet," Dill said of the current budget issues created by cuts from state funding and a drop in property tax revenues.

It is challenging to take over when things are at their worst, he said, but he said he remains "cautiously optimistic."

Collision involving bicycle sends two to hospital

On Monday, Aug. 2, at 3:14 p.m., firefighters from the Rancho Santa Fe Fire Protection District (RSFFPD) responded to a bicycle vs. vehicle collision just east of the intersection of Camino del Norte and Dove Canyon Road in 4S Ranch. When they arrived at the scene, emergency personnel found that the driver of an SUV had lost control of the vehicle rolled several times, hitting a bicyclist in the process. Both the driver, a 17-year-old female, and the bicyclist, a 29-year-old female, were transported to Palomar Medical Center in Escondido for evaluation of their injuries. The California Highway Patrol is handling the investigation.

Many crews scheduled for high-rise fire drill

ESCONDIDO — Crews from 15 agencies are expected to participate in a high-rise fire drill Saturday at the Palomar Medical Center West construction site.

What makes this fire drill unusual is the number of agencies involved, said Palomar Pomerado Health spokesman Andy Hoang. The hospital district is expecting about 100 people participating in the drill, for which the Escondido Fire Department is the lead agency.

This is the second high-rise fire drill at the hospital construction site, south of state Route 78. A drill in January involved firefighters from Escondido and San Marcos.

Agencies have sought out this site, Hoang said. There's nothing of this magnitude — 11 stories with open steel beams and elevator shafts — in the area for drills.

The drills will start about 10 a.m., with crews scaling and rappelling the steel beams of the new hospital with dummy patients.

The hospital, in the city's Research and Technology Center, is expected to open in early 2012, Hoang said.

The participating agencies are: Escondido, Vista, Oceanside, San Pasqual Reservation, Encinitas, Rincon, Pauma Reservation, Pala, National City, Ramona, Camp Pendleton and Elfin Forest/Harmony Grove fire departments; Rancho Santa Fe Fire Protection District; Cal Fire; and North County Fire Protection District.

Critics Speak Out About Shelter In Place Option

Cielo, 4S Ranch, Bel Etage, Salviati, Savenna, The Bridges, Crosby and The Lakes Are Shelter In Place **Communities**

SAN DIEGO -- In eight newer developments in North County, families have the shelter in place option to stay during a brush fire, but one critic is calling it a potential death trap.

When Shaunna Salzetti redesigned the landscaping for her Cielo home, she had to meet strict fire guidelines.

"I think the biggest deal with landscaping was the requirement with the trees," said Salzetti. "We had to plant the trees in groups of three."

Every plant, shrub and tree had to pass a fire district inspection.

"The cypress trees... they call 'roman candles' so they had to be at least 30 feet away from the structure," said Salzetti.

Cielo is one of eight North County neighborhoods specifically built to be shelter in place communities. The others are 4S Ranch, Bel Etage, Salviati, Savenna, The Bridges, Crosby and The Lakes.

"Our shelter in place is unique because you could stay and survive," said Cliff Hunter, the fire marshal for the Rancho Santa Fe Fire Protection District where all 2,400 shelter in place homes are located.

"It gives the homeowner a choice, in a fire, if they see one coming, do I stay or do I go," said Hunter.

During the last fire storm, not one shelter in place home was lost and only one 4S Rancho house was damaged.

But shelter in place is not without critics.

"It's a fool's errand to think you can make this work," said critic Bruce Tebbs from the Deer Springs Fire District.

He said developers use shelter in place to get dense housing projects approved in areas difficult to evacuate.

"They cannot get the projects through following the state fire code," said Tebbs.

He said unpredictable wildfires are likely to cause panicked people to flee their homes too late when it is the most dangerous.

"This is the only county in America to my knowledge where they allow that," said Tebbs.


