RANCHO SANTA FE FIRE PROTECTION DISTRICT REGULAR BOARD OF DIRECTORS MEETING MINUTES – November 18, 2009

President Ashcraft called to order the regular session of the Rancho Santa Fe Fire Protection District Board of Directors at 1:05 pm.

Pledge of Allegiance

Deputy Chief Tony Michel led the assembly in the Pledge of Allegiance.

2. Public Comment

3. Special Presentations

a. Painting Presentation

Chief Pavone introduced Leila Hazery, student at Santa Fe Christian School and her guests. She presented her painting "Out of the Ashes" to the Fire District in which she expressed her appreciation for the hard work of all firefighters. Chief Pavone acknowledged her efforts and thanked her for her donation to the District.

b. Plaque Presentation

Chief Pavone and Captain Mike Shore, representing the Professional Firefighters Association Local 4349, presented plaques of appreciation to Matt Basham, RSF Village Market; Hank Mendez, RSF School District; and Tim Cusac, Café Positano for their support and donations to the District's annual pancake breakfast. This year, approximately 700 meals were served in a four hour period. Through everyone's support, this annual event was another success. Chief Pavone also complimented Captain Shore for his time and efforts in making the event successful.

a. Contract: Shared Liability Agreement – Hiring Consortium

Chief Michel summarized the staff report provided. The District has been a member of the hiring consortium for the past 18 years, which conducts the physical ability testing for entry-level firefighter/paramedic. He reported that a recent review conducted of the consortium's policies, it was determined that a shared liability agreement for workers compensation was never signed by all participating member agencies. If approved, the District's liability exposure is shared by all members and will be limited to ten percent (10%) for any claim. For workers compensation, the Fire District is a member agency to PASIS (Public Agency Self Insurance System) and legal counsel for PASIS prepared the agreement. A separate review of the agreement was provided by the Fire District's legal counsel. Staff responded to questions from the Board.

MOTION BY DIRECTOR HICKERSON, SECOND BY DIRECTOR MALIN, and CARRIED 5 AYES; 0 NOES; 0 ABSENT; 0 ABSTAIN to approve the District's continued participation in the hiring consortium and authorize the President to sign the agreement for workers compensation coverage for participants in firefighting testing.

b. Budget Authorization

Chief Pavone summarized the staff report provided. The Fire District has developed a replacement schedule to upgrade the radios needed for inter-operability. The request is to replace four (4) radios, which were identified

in the FY10 budget. He noted that the radios were originally purchased via a grant, and some replacements have been purchased also with grant money. Staff responded to questions from the board.

MOTION BY DIRECTOR HILLGREN, SECOND BY DIRECTOR HICKERSON, and CARRIED 5 AYES; 0 NOES; 0 ABSENT; 0 ABSTAIN to authorize the purchase of four replacement radios at \$3,924 (plus tax) for each radio.

8. Oral Reports

a. Fire Chief - Pavone

He reported on the following topics:

- Fairbanks Ranch Replacement Fire Station Update
 - o Interim Fire Station the trailers have been delivered and are on site. The contractors have begun the minor grading necessary on the site. The infrastructure necessary includes water; sewer and power are complete; however, there have been challenges with establishing phone service. He anticipates a move in time of 3-4 weeks.
 - Station Demolition he continues to work with the architect for the demolition which will occur in the December/January period. He informed the Board that the District could not perform any grading between January 15 and May because of environmental issues, unless all trees are removed.
 - o New Construction no additional information.
- Management Services Contract The leadership task force held their first meeting on November 18
 to discuss the performance of the first 30-days. To date, the responses from all agencies have been
 positive.
- District Activities
 - o CERT Graduation: scheduled for Saturday, November 21st. The Fire District has ten citizens in the class.
 - o Holiday Party: scheduled for December 18th at The Inn at Rancho Santa Fe.
- b. Operations Deputy Chief Michel

He reported on the following topics:

- Significant calls include:
 - o Traffic collision on San Dieguito Road resulting in one fatality
- Recruitment for Firefighter/Paramedic positions: two conditional offers of employment have been made with an anticipated date of hire December 7, 2009.
- Promotion: two positions will open in late December resulting from two retirements (Lutz & Foster). As a result of the promotional testing and interviews, the following personnel were selected:
 - Engineer Dave McQuead Captain (retirement of Captain Lutz)
 - o Firefighter/Paramedic Tim Wood Engineer (promotion of Engineer McQuead)
 - o Captain Chris Galindo Temporary Administrative Captain
 - o Engineer Bruce Sherwood Temporary Acting Captain (reassignment of Captain Galindo)
 - o Firefighter/Paramedic's Brandow and Lorenzo Temporary Acting Engineer (a shared acting

- Temporary Captain position to fill vacant worker's compensation captain position to be shared by Engineers' Bispham, Jordan, Ligtenberg, and Slattery.
- c. Training Battalion Chief Davidson

Chief Michel summarized the monthly training activity, which included:

- RSF Personnel participated in:
 - o Fire prevention classes to the schools
 - o Zone high rise
 - Field care audits
- d. Fire Prevention Fire Marshal Hunter
 - Presentation: Public Relations Coordinator Julie Taber: distributed statistics on the number of children (3,600) at 11 schools that were educated during the month of October for fire prevention.
 She reviewed the curriculum presented to the children and prepared by the Burn Institute. She has requested feedback from the teachers and District personnel for any suggested improvements for the next year.
 - Distributed the statistics regarding the "dead trees." To date, he has authorized seven (7) forced abatements. He assured the board members that every effort is made to get the property owner to comply with the ordinance before he authorizes the work for abatement.
 - Construction statistics are low this month.
- e. Administration Administrative Manager Rannals
 - Proposition 1A Receivable Financing Program Update: She reported that the application process
 was completed and accepted by California Communities. The District's receivable, certified by the
 County of San Diego, is \$780,226.
 - CalPERS Conference: all participants who attended the conference (Director Malin, Deputy Chief Michel, and Karlena Rannals) shared their experience and discussed the future costs of the retirement benefits offered to District employees.







BACKGROUND

The current Memorandum of Understanding with Rancho Santa Fe Fire Protection District Employee's Association expires June 30, 2010. The District recently concluded negotiations with the Firefighters Association and management personnel. One provision that changed for both represented groups was the volume of life insurance purchased by the District beginning December 1, 2009.

CURRENT SITUATION

Lincoln Financial Group has informed the Fire District that the Employee's Association, as a part of District's group life insurance plan, cannot have a lower volume of insurance, currently set at \$10,000. The Board of Directors has agreed to increase volume from \$10,000 \Rightarrow \$25,000 for suppression personnel, and increase volume from \$25,000 \Rightarrow \$50,000 for management personnel. Therefore all covered members within the "Employees Association" must be increased from \$10,000 \Rightarrow \$25,000.

The District and the representatives of the Association held discussions regarding the increased insurance, and the representatives of the Association and the District have agreed to the change.

RECOMMENDATION

Approve the side letter as prepared, which allows the improvement of life insurance from \$10,000 → \$25,000 beginning December 1, 2009.

SIDE LETTER No. 3 TO THE MEMORANDUM OF UNDERSTANDING

between

Rancho Santa Fe Fire Protection District

and

Rancho Santa Fe Fire Protection District Employees Association

This is a side letter number 3 to the Memorandum of Understanding effective 12:01 a.m. on July 1, 2006 through 12:00 midnight on June 30, 2010 between the Rancho Santa Fe Fire Protection District, herein referred to as "District," and Rancho Santa Fe Fire Protection District Employees Association, herein referred to as "Association."

It is agreed that Article 22.02 shall be added as a provision to the Memorandum of Understanding:

ARTICLE XXII – LIFE INSURANCE

22.01 [No change to the current MOU.]

22.02 The District shall improve the life insurance policy to \$25,000 beginning December 1, 2009. All other provisions identified in 22.01 shall remain the same.
