FORESTRY ASSISTANT *Fuels and Fire Management*

(TEMPORARY POSITION) Salary: \$12.00 / hour (no benefits) Application Deadline: Friday, May 26, 2017 at 5:00pm

The Rancho Santa Fe Fire Protection District (RSFFPD) is currently seeking applicants to fill a summer internship position. The successful candidate for this position *will work 40 hours per week during the summer of 2017. Applicants will be interviewed on-site at the beginning of June 2017.*

EXAMPLE OF DUTIES:

- Inspect Shelter-in-Place Communities for compliance with 2016 California Fire Code. *Uniform will be provided*.
- Enforces RSFFPD's local ordinances for vegetation management.
- Provide daily inspections, cleaning, and refueling services, as necessary, of staff vehicle assigned to the Forestry Assistant.
- Performs other Fire Prevention related duties as assigned by the Fire Prevention Specialist II / Forester or Fire Marshal.

MINIMUM QUALIFICATIONS:

Age: Minimum age of 18 years is required.

Health: Applicants must be in good physical conditions, with the ability to perform all tasks assigned. Must be capable of lifting up to 50 pounds without assistance. Must be a non-smoker.

Education: Preferred applicant to be currently enrolled in a four year college degree program with an emphasis in fire and fuels management and/or fire prevention.

Experience: Microsoft Office Suite (Word, Excel, and Outlook) software is strongly desirable. Creating and editing ARCGIS Geographical Information System Maps is also desirable.

Housing: Applicant must provide for their housing during employment.

Driving History: A RSFFPD-owned vehicle will be provided to complete work while on-duty. Applicants must possess a valid "Class C" California driver's license with an acceptable driving record throughout employment with RSFFPD. Applicants must submit a current Department of Motor Vehicle (DMV) history report covering the last two years with the application.
