# **BACKGROUND**

The Fairbanks Ranch fire station was built in 1983. At that time, fire station was not outfitted with an emergency back-up generator. In the mid to late 1990's the fire district relocated a used emergency back-up generator from the Rancho fire station to the Fairbanks Ranch fire station. The emergency generator was only used as a means to back-up the computer aided dispatch (CAD) alerting system as well as a few other outlets.

# **CURRENT SITUATION**

The Fairbanks Ranch fire station is in the process of being replaced. The new replacement fire station is planned to be built with the current standard for emergency back-up power. This would be a self-contained emergency generator that would meet the needs of the replacement station. The existing generator is not adequate to supply the needs of the replacement station.

We have contacted our local vendor to see if they had an interest to purchase the old generator but they were not interested. We had our fleet maintenance vendor give use an estimate of the value and he estimated it to be in the range of \$425 to \$1,000. We have a San Diego County Fire Agency interested in purchasing the used generator. The agency has offered to the purchase the generator (as is) from the fire district for \$750.

## **OPTIONS**

- 1. Utilize the County of San Diego's auction vendor and take what we can get.
- 2. Sell the generator to Viejas Fire Department for \$750.

# RECOMMENDATION

Staff recommends that the District sell the surplus generator to Viejas Fire Department.
