

# RANCHO SANTA FE FIRE PROTECTION DISTRICT REGULAR BOARD OF DIRECTORS MEETING MINUTES – April 11, 2007

Karlena Rannals summarized the staff report included. She reported that the Public Agency Self Insurance System (PASIS) Board of Directors desires to amend the Joint Powers Agreement to update the governing documents to reflect the current practice. The governing documents will not become effective until a two-thirds majority of the PASIS member agencies approves it.

### 7. Oral Reports

- a. Fire Chief Pavone
- Cooperative Effort

He informed the board members that John Traylor, consultant for the City of Solana Beach, has completed the analysis for cooperative effort opportunities between Rancho Santa Fe Fire Protection District and the City of Solana Beach and City of Del Mar Fire Departments. He anticipates that Mr. Traylor will have a report for the Board at the next meeting. He noted that once the report has been presented, each agency would then need to determine if they are interested in pursuing any cooperative efforts. He responded to questions from the Board.

LAFCO Micro Study

He reported that the public hearing for the Proposed Reorganization of Structural Fire Protection and emergency medical Services in Unincorporated San Diego county will be help May 7, 2007. He reported that the San Diego County Fire Chiefs Association voted to support the original SSP (Similarly Substantial Proposal) and offered a letter of support with stipulations. He encouraged all board members to attend the hearing.

#### Strategic Plan

He informed the board members on the progress of the Strategic Plan Committee and that they are in the process of finalizing the revised plan for review. He intends to include the updated strategic plan on the agenda next month for discussion. The board members requested that he send the document as soon as it becomes available.

#### District Activities

- CERT Program: 170 participants attended the countywide drill held at RSF2. Captain Mertz, CERT Program Coordinator did an excellent job facilitating the drill.
- Cell Site Report: he received the results from radio frequency testing analysis from the consultant and the results are significantly below the acceptable levels.
- Relocation of RSF Association Patrol: the Association is attempting to press forward with a land swap to relocate Patrol. The Fire District has been requested to participate at a neighborhood meeting to answer any questions on this matter.
- Appreciation Dinner: a reminder that the annual dinner is scheduled for April 20<sup>th</sup>.

## b. Operations – Deputy Chief Michel

He reported on the following topics:

- Call activity, in particular the structure fire on Los Colinas and two major traffic collisions
- A conditional offer of employment was made to fill the current Firefighter/Paramedic vacancy.
- The recruitment for Battalion Chief is posted and the District is accepting applications.

### c. Training – Battalion Chief Sturtevant

District personnel will participate in the upcoming wildland and structure protection drill to be held on the Barona Indian Reservation.

#### d. Fire Prevention - Fire Marshal Hunter

He reported on the following topics:

- Plan reviews increased in the previous month. He is dealing with many difficult parcels.
- He has an opportunity to promote the District's Shelter in Place communities and is scheduled to be interviewed by Channel 8
- He has received three applications for the summer intern position.

- North County Dispatch JPA Update Director Ashcraft: no report
- County Service Area 17 Update Director Hickerson: he reported that there was not a meeting; however, the County is requesting that the District consider designating an alternate. Chief Pavone asked if the Board of Directors want to use District staff time to analyze the pros, cons, and costs to reorganize with Elfin Forest Volunteer Fire Department. At the conclusion of the discussion, the Board concluded that staff should most likely look at the option of reorganizing; however, nothing will be pursued until after the LAFCO hearing on May 7.
