a. <u>Fire Chief</u>

- He expressed his appreciation to members of the Staff for the extra time and effort spent to perform the extra work resulting from all of the promotions.
- LAFCO Study Consolidation Update: he reported that the County Fire Chiefs and Fire Districts requested that Supervisor Dianne Jacobs provide monthly updates on the progress of identifying the funding for a consolidated agency.

- Regionalization Study (ESCI) Update: no report.
- Acquisition of Real Property Agreement for the Replacement of the Fairbanks Ranch Fire Station Update: he reported that he spoke with the church Pastor Ramage on the status of the agreement. Pastor Ramage informed Chief Pavone that the Church Board of Directors had not made a final decision on the revised contract language. Chief Pavone informed the board members that he is looking at other possible sites to relocate the station.
- The plans for the Administration Building remodel were resubmitted with corrections to the County of San Diego for review. Upon approval, the District will go to bid on the construction project.

  - Monthly Report December 2005 Chief Michel distributed the monthly report and reviewed the statistics on call types and response times. He also reported that in early January District personnel responded to a fire in which a sprinkler head put out the fire. The damage was confined to the cabinet area in the laundry.
