8. New Business

 Contract: Duty Coverage between Rancho Santa Fe Fire Protection District and Solana Beach and Del Mar Fire Departments

Chief Pavone summarized the staff report included with the agenda material. He reported that the agreement formalizes a long-standing practice of duty coverage, and allows the RSF Battalion Chiefs to gain additional experience and to build relationships with neighboring jurisdictions.

Staff responded to questions from the Board, including questions regarding the minimum level of

liability insurance. The Board requested that Staff verify the levels of insurance prior to signing the contract.

MOTION BY DIRECTOR DOUGLAS, SECOND BY DIRECTOR MALIN, and CARRIED 4 AYES; 0 NOES; 1 ABSENT; 0 ABSTAIN to approve the contract for *Duty Coverage between Rancho Santa Fe Fire Protection District and Solana Beach and Del Mar Fire Departments*, and authorize the Fire Chief to execute the contract, after verifying the insurance.

b. Contract: Settlement Agreement and Mutual Release between Santa Fe Irrigation District and Rancho Santa Fe Fire Protection District

President Ashcraft reminded the board members that this item was added to the agenda and the contract requires approval resulting from the closed session discussion.

MOTION BY DIRECTOR DOUGLAS, SECOND BY DIRECTOR MALIN, and CARRIED 4 AYES; 0 NOES; 1 ABSENT; 0 ABSTAIN to approve the Settlement Agreement and Mutual Release between *Santa Fe Irrigation District and Rancho Santa Fe Fire Protection District* and authorize the President to execute the contract.

- a. Fire Chief Chief Pavone
 - Cooperative Effort Study (*Del Mar/Elfin Forest/Rancho Santa Fe/Solana Beach*): he reports that he continues to meet semi-monthly with the representatives of the study. The City of Encinitas has expressed an interest in participating in the study. All representatives have agreed to study a specific list of items. The consultant, John Traylor intends to prepare a staff report that will update the Board on his progress.
 - Personnel Update Firefighter/Paramedic Blake Dorse accepted a position with the City
 of Oceanside. Recruitment is in progress to fill two vacant positions and testing is
 scheduled for November 28 and 29.
 - Community Activity Update:
 - O He reported that the Department served breakfast to 294 people and approximately 50 people at the spaghetti dinner in conjunction with the District's 60th anniversary on October 29.
 - Holiday Party December 8, 2006 reminded the board members of the event. All questions can be directed to the event chair Paul Lorenzo.

Director Hillgren departed the meeting at 2:00 pm.

b. Operations – Deputy Chief Michel

- Monthly Report October 2006 he summarized the monthly activity including:
 - o 2692 (new ambulance located at RSF2) responded to 25 calls, of which 11 were after hours.

- Monthly Report October 2006 Fire Marshal Hunter summarized the monthly activity. He noted that plan review activity has decreased; however, because of the shopping center in the 4S Ranch area, inspections have increased.
- Fire Prevention Week Activity Report Julie Taber, Public Relations Coordinator summarized the activities that included presentations to 12 schools that totaled 56 presentations and reached 2,634 students. Each student was provided a "goodie bag." The District received positive feedback from the schools. Chief Pavone congratulated Julie and all of the suppression personnel for their efforts and the success of the presentations.

 - o The center will expand to eight consoles
 - o The recruitment for a new Administrator continues. Interviews are scheduled for December.
- ii. County Service Area 17 Update (Hickerson)
- Chief Pavone provided the report in Director Hickerson's absence. A meeting was held on November 7. The RFP is to be distributed November 30 for a new paramedic transport provider. The CSA-17 Fire Chiefs are working with County of San Diego EMS staff to make changes in future contracts that will provide a better level of service.

iii. Comments

- Douglas expressed his appreciation for the gift and thanked the community for the opportunity to serve. He also encouraged the Board to continue an effort to quantify the progress of the District's problems, including the Gann Limit and find an objective anonymous method to solicit feedback from the public.
- Ashcraft he expressed appreciation to Director Douglas for his contributions to the Fire District and the community.
