## JOB ANNOUNCEMENT (Internal Recruitment)

### Part-Time Firefighter Driver Operator

**APPLICATION PERIOD OPENS: Open until filled**

#### GENERAL DESCRIPTION:

The Part-Time Firefighter Driver Operator (PTFFDO) classification is a temporary part-time safety position and falls under the Operations Division – RSF Station 6 Volunteer Program. PTFFDO's are "at will" employees and work under the parameters of an Employment Agreement. The part-time work schedule is based on a twenty-eight hour work week, 24 hours on, 72 hours off, 24 hours on, 144 hours off shift schedule (four 24 hour shifts in a 24 day work period).

The position works under the direct supervision of a Company Officer. The work involves participating in duties of protecting life and property through the performance of firefighting, rescue, and emergency medical service activities. The position requires all fire suppression, rescue and EMS related skills required of a firefighter and may be directed to perform any or all of those skills. The position requires working in a hazardous atmosphere both in an individual capacity as well as a team member.

#### EMPLOYEE BENEFITS:

- **Compensation:** California State minimum wage.
- **Sick Leave:** 24 hours annually (non-accruing) An employee is entitled to use paid sick leave beginning on the 90th day of employment.
- **Retirement:** Public Employees' Retirement System - Safety 2.7% @ 57. Classic employees will be enrolled in the Safety 3%@ 55 plan.
- **Tuition Reimbursement:** Based upon the District's guidelines, with prior written approval.
- **Uniforms & Safety Gear:** The District will provide any uniforms, tools and equipment as the Fire Chief or his/her designee deems appropriate.

#### MINIMUM QUALIFICATIONS:

- Must be 18 years of age at date of application.
- Must possess a current State of California Certified EMT or Paramedic license accredited in San Diego County.
- Must have and maintain a class "B" driver's license or a class "C" license with firefighter endorsement without record of suspension or revocation.
- Must be currently certified as a RSF Driver Operator.

#### WHO MAY APPLY:

This is an internal District recruitment and the position is open to anyone, paid or volunteer, who meets the requirements set forth in this job announcement. Applicants must submit an official Fire District application form and resume outlining qualifications and experience.
