#### 8. New Business

## a. Acceptance of Donation

Chief Cox summarized the staff report provided. He reported that staff recommends accepting a grant award for \$110,000 from the Rancho Santa Fe Fire District Foundation while maintaining a \$33,800 commitment in District matching funds. The grant is to reimburse the District's General fund for the recent replacement of the septic system at RSF6. He also noted that staff also recommends the approximate \$7,677 in excess funding be authorized for landscape/parking lot improvements for Fire Station 6. Staff responded to questions from the Board.

Representatives from the Rancho Santa Fe Fire District Foundation, Mr. Tim Constanzo, Mrs. Nona Barker and Mr. Jim Depolo, President presented a check to President Jim Ashcraft and Fire Chief Fred Cox. President Ashcraft on behalf of the District conveyed the District's appreciation for the grant and support to the Fire District.

## b. Independent Auditor's Report FY 2017/2018

Director Malin reported that the finance ad hoc committee (Directors' Malin and Tanner, Chief Cox and Karlena Rannals) met with Gary Caporicci, CPA from the Pun Group to review the draft audit report for FY18.

He reminded his board colleagues of the financial statements requirement (GASB 68), which reports the full pension liability. Although the board has taken action to make accelerated payments to reduce the District's pension obligation, it has slightly increased because of the poor investment performance of CalPERS and the reduction of the discount rate. In addition, the auditor reviewed the internal controls that staff has in place and perform various testing of accounts.

Director Malin informed the Board that the ad hoc committee was satisfied with the discussion in the meeting; the District received a clean report from the auditors and recommended that the Board accept the report as distributed. The ad hoc committee responded to questions from the Board.

MOTION BY DIRECTOR MALIN, SECOND BY DIRECTOR TANNER, CARRIED 4 AYES; 0 NOES; 1 ABSENT; 0 ABSTAIN to accept the FY 2017/2018 independent audit prepared by The Pun Group as distributed.

## 9. Oral Report

- a. Fire Chief Cox
  - i) District Activities
    - RSF5 Construction: the district has received the final conditions letter from the County of San Diego, which must be met before the building permit will be issued. There are five conditions, of which two are significant. The first is filing an easement giving the County a 50-foot easement on

the property. Legal counsel is working on the easement language. He noted that to move the project forward, he would most likely request a special meeting. Another condition that must be met is the storm water runoff, which will add \$100,000 to \$200,000 to the cost. These two of the five conditions will significantly affect the cost of the project.

- 2. RSF6 Septic tank is complete and operating. Again, a special thanks to the RSF Fire District Foundation for the grant.
- 3. He has been contact with the North County Dispatch JPA Administrator who is interested in renting additional space at the El Fuego location. Thru tenant improvements and a relocation of another tenant, this may be worth pursuing for long-term leases.
- 4. Badge Presentation reminder that the badge ceremony is scheduled for February 20.
- 5. Fuel Abatement CalFire has money in the County to increase their fire prevention efforts, specifically fuel abatement.
- b. Operations Deputy Chief Chief McQuead summarized t

Chief McQuead summarized the previous month's activity and year's statistics, noting the call load for 2018 was 3,745 an overall increase in calls of 4.62%.

- c. Elfin Forest Volunteer Division Division Chief
   VRRC Twohy reported that ten volunteers on the roster are in medic school. The volunteers contributed
   1,320 hours the previous month. They are in the middle of a volunteer recruit academy.
- d. Training Battalion Chief Chief Sherwood reported that there is 98 hours of scheduled training. The District completed an audit with a 100% success rate in compliance with all mandated training. Personnel also participated in training fir high angle rescue and active shooter training.
  e. Fire Prevention – Fire Marshal
- e. Fire Prevention Fire Marshal FM Donner reported that the District would participate in Love Your Heart day on February 14. Staff is working on the annual weed abatement mailer, and the District added nearly 2.3 million square feet of new construction in the previous month.

#### AMENDMENT NO. 5 TO BUILDING LEASE AGREEMENT

This Fifth Amendment to Lease (the "Amendment") is made this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_, by and between **Rancho Santa Fe Fire Protection District, a California public agency** ("Lessor"), and **Verizon Wireless** (VAW) LLC, dba Verizon Wireless ("Lessee"), with reference to the facts set forth in the Recitals below:

# RECITALS

A. Lessor is the owner of certain real property located at 16936 El Fuego, Rancho Santa Fe, California (the "Property"), which Property is further described in the Lease (defined below).

B. Lessor and Lessee are parties to that certain Building Lease Agreement dated October 18, 1994, as amended by that certain Amendment No. 1 to Building Lease Agreement dated March 31, 1998, as further amended by that certain Amendment No. 2 to Building Lease Agreement dated September 30, 1999, as further amended by that certain Amendment No. 3 to Building Lease Agreement dated October 13, 2006 ("Third Amendment") and as further amended by that certain Amendment No. 4 to Building Lease Agreement dated September 10, 2015 (as so amended, the "Lease"), pursuant to which Lessee is leasing from Lessor space within and on the building ("Building") at the Property, together with the right of access to and from the nearest public right-of-way and the right to install utilities (the "Premises"). The Lease is currently scheduled to expire pursuant to its terms on November 21, 2019.

C. Lessor and Lessee have agreed to amend the Lease to (i) extend the term of the Lease; and (ii) modify certain other provisions of the Lease, as provided herein.

## AGREEMENT

NOW, THEREFORE, in consideration of the facts contained in the Recitals above, the mutual covenants and conditions below, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. **Extension Terms**. Commencing on November 1, 2019, Lessor and Lessee hereby agree to extend the Lease for an additional term of five (5) years. Thereafter, the term of the Lease shall automatically be extended for four (4) additional extension terms of five (5) years each, unless Lessee terminates the Lease by giving Lessor written notice of the intent to terminate at least sixty (60) days prior to the end of the then-current term.

2. Annual Rental Escalations. The annual rental adjustment provided in Section 1 of the Third Amendment is hereby deleted in its entirety and amended to be as follows: "Commencing on November 1, 2019, and on each November 1 thereafter, Lessee's annual rent shall be increased by an amount equal to 2% of the annual rent in effect during the immediately preceding lease year."

<u>2.</u> <u>3.</u> <u>Continued Effect.</u> Except as specifically modified by this Amendment, all of the terms and conditions of the Lease shall remain in full force and effect. In the event of a conflict between any term or provision of the Lease and this Amendment, the terms and provisions of this Amendment shall control. In addition, except as otherwise stated in

this Amendment, all initially capitalized terms will have the same respective defined meaning stated in the Lease. All captions are for reference purposes only and shall not be used in the construction or interpretation of this Amendment.

# **RECOMMENDATION:**

Staff recommends the Board of Directors approve and authorize the Fire Chief to enter into the North Mutual Threat Zone Agreement.

# BACKGROUND:

The Rancho Santa Fe Fire District is bordered by three cities who are not dispatched by North County Dispatch Joint Powers Authority (NCDJPA). To better facilitate a coordinated response to wildland fires with these bordering cities, a *North Mutual Threat Zone Agreement* was developed. Under the agreement, all agencies when responding within the identified mutual threat zone (see attached map) agree to operate on a common communications plan under one command/communication center. This will provide for better command and control and prevent duplication of resource requests.

Rancho Santa Fe Fire Protection District currently operates in this manner with other North Zone agencies and Cal Fire and no change in operational procedures is required.

Legal counsel has reviewed and approved the content of this agreement.

# COOPERATIVE FIRE PROTECTION AGREEMENT Between CITY OF SAN DIEGO FIRE-RESCUE DEPARTMENT And ESCONDIDO FIRE DEPARTMENT And RANCHO SANTA FE FIRE DEPARTMENT And POWAY FIRE DEPARTMENT And CALIFORNIA DEPARTMENT OF FORESTRY AND FIRE PROTECTION (CAL FIRE-SAN DIEGO UNIT)

WHEREAS, CITY OF SAN DIEGO FIRE-RESCUE DEPARTMENT maintains and operates a fire protection organization in the area generally known within the City of San Diego; and

WHEREAS, ESCONDIDO FIRE DEPARTMENT maintains and operates a fire protection organization in the area generally known within the City of Escondido: and

WHEREAS, RANCHO SANTA FE FIRE DEPARTMENT maintains and operates a fire protection organization in the area generally known as Rancho Santa Fe: and

WHEREAS, POWAY FIRE DEPARTMENT maintains and operates a fire protection organization in the area generally known as City of Poway: and

WHEREAS, CALFIRE maintains and operates a fire protection organization for the purpose of providing "basic" protection to the State Responsibility Area lands.

NOW THEREFORE, the parties hereto mutually agree as follows:

- 1. PARTIES agree to the Mutual Threat Zone as defined on map (Attachment A).
- 2. PARTIES agree to provide immediate notification of all fire emergency incidents/threats to the other agency through established procedures in each agencies Command/Communication Center. This includes immediate notification to other agencies signature to this agreement.
- 3. PARTIES agree to utilize the assigned VHF frequencies as defined in the 217A Zone Communications Plan (Attachment B) for incidents within the Mutual Threat Zone.

- 4. PARTIES agree to a single Unified Ordering Point pre-determined as the Monte Vista Interagency Command Center (MVICC).
- 5. PARTIES agree to utilize Unified Command based on Mutual Threat Zone jurisdictional authority or threat to Jurisdictional Authority. A Unified Command Post will be established.
- 6. PARTIES agree that consideration of cost share shall be determined during extended or major fire incidents. Such costs will be determined through a separate agreement outside of this Mutual Threat Zone agreement.
- 7. Each party hereto shall indemnify, defend, save and hold harmless the other parties, and each of them and their respective agents, servants and employees, of and from any and all liabilities, claims, demands, debts, suits, actions and causes of action arising out of, or in any manner connected with, any act or omission of such indemnifying party hereunder or its agents, servants, or employees, done or performed pursuant to the terms and condition hereof or arising upon or within the property of such indemnifying party as herein set forth after the date of expiration of the Agreement.
- 8. Except as may be provided by separate written agreement between the parties, no party shall be obligated to reimburse hereunder, or for any use of material, damage to equipment, or liability incurred which may occur in the course of rendering the firefighting assistance herein provided.
- 9. Nothing contained herein shall be construed as a contract under law or equity for the benefit of any third party, which may be affected by the Agreement.
- 10. Nothing in this agreement shall preclude any party from exercising its right to seek recovery of costs pursuant to Health and Safety Code sections 13009 and 13009.01.
- 11. Any PARTY may terminate this Agreement upon ninety (90) day written notice to the other PARTIES. The PARTIES may only modify this Agreement by a writing signed by all PARTIES.
- 12. PARTIES agree to meet annually to review/validate this Mutual Threat Zone agreement.

#### RECOMMENDATION

Staff recommends the Board of Directors proceed with the adoption process of Ordinance No. 2019-01 that repeals Ordinance No. 2016-01 and authorizes changes to the District's current fee schedule.

#### BACKGROUND

On May 18, 2016, the Board of Directors adopted Ordinance No. 2016-01 to update the District's schedule of fees to achieve cost recovery for the delivery of certain Fire Prevention and other District services. Fees for service are authorized pursuant to the *California Health and Safety Code, Section 13916*. Fees shall not exceed the costs reasonably borne by the District in providing the service or enforcing the regulation for which the fee is charged.

Ordinance No. 2016-01 requires an update to reflect new fee categories and the actual the cost of providing such services. Staff also recommends a new methodology for fee calculation that provides a better means to identify the cost of providing such services. The new fee calculation is based upon (activity processing time) + (plan review time) + (field inspection services) + (direct/indirect costs) = fee incurred. The criteria is defined below:

Activity Processing Time: The estimated average time it takes to process an activity, including intake services, data entry, scheduling, and any other work associated with the activity. The fee is calculated at the fully burdened hourly rate for an office support coordinator.

**Plan Review Time:** The estimated average time it takes to conduct a plan review. The fee is based off the fully burdened hourly rate of the position identified in the assigned duty column.

**Field Inspection Services:** The estimated field inspection time, including travel time to/from the administrative offices, to conduct the inspection activity. The fee is based from the fully burdened rate of the position identified in the assigned duty column.

**Direct/Indirect Costs:** These are fully burdened expenses, both labor and non-labor, that are related to the District's agency-wide support services. Labor related support

services include general administrative services such as Fire Chief, Human Resources, Finance, and Payroll etc. Costs for indirect agency-wide labor are calculated by: (fully burdened labor cost) x (percentage assigned to prevention) x (percentage assigned to the activity). Example - Accounting Specialist: burdened hourly rate (\$48) x percentage assigned to prevention (2%) x percent assigned to activity (65%) = \$1 assigned to the hourly rate for direct/indirect labor costs.

Non-labor costs are average costs to support fire prevention services. Non-labor costs are calculated by (audited dollar amount expended for a budget category) + (estimated percentage assigned to prevention) + (the percentage assigned for the activity). Example - Office Supplies: audited expenditure for budget category (\$13, 474) x estimated percentage assigned to prevention (15%) x the percentage assigned for the activity (65%) divided by (2,080) the number work hours per year = .63 cents added to the hourly rate.

The new fee calculation method is modeled in Excel and can be easily updated as required by updating new base numbers.

# ORDINANCE No. 2019-01

AN ORDINANCE OF THE BOARD OF DIRECTORS OF THE RANCHO SANTA FE FIRE PROTECTION DISTRICT ADOPTING FEES FOR SERVICES BY REFERENCE TO THE CALIFORNIA HEALTH AND SAFETY CODE SECTION 13916 AND SECTION 13919 AND REPEALING ORDINANCE 2016-01.

The Board of Directors of the Rancho Santa Fe Fire Protection District of the County of San Diego ordains as follows:

**ARTICLE I.** The Rancho Santa Fe Fire Protection District has incurred un-reimbursed discretionary development costs and is anticipating that further new discretionary development will occur within the District, which will place a greater demand on the existing staffing resources of the fire prevention bureau. Escalating demands have also been placed upon suppression personnel in conducting increasingly numerous and complex occupancy inspections.

**ARTICLE II.** The Rancho Santa Fe Fire Protection District is charged with the responsibility of enforcing applicable codes pertaining to fire and panic safety and other regulations of the State Fire Marshal pursuant to Section 13146 of the California Health & Safety Code.

**ARTICLE III.** The Rancho Santa Fe Fire Protection District incurs additional costs in lost personnel hours and expended District resources when said fire prevention services are of a recurrent nature and the result of discretionary development. The District charges fees to recover costs incurred for the provision of said services, however, said fees require periodic revision to reflect current personnel costs.

**ARTICLE IV.** The Fire Chief may impose a fee for recovery of expenses incurred as a result of activities undertaken pursuant to enforcing the fire prevention provisions of the fire code, pursuant Health and Safety Code Section 13916 and 13919 and Govt. Code Section 66014.

**ARTICLE V.** Fire District fees are based upon the actual costs incurred by the fire agency, which are based upon the total compensation of the employee(s) providing a particular service and include total personnel hours utilized for plan review, file review, database information entry, travel to and from the site, written response, site inspection, and support costs.

**ARTICLE VI.** The actual fee shall be paid by the applicant to the fire district at time of application or submittal to cover the actual costs in accordance with the aforementioned schedule for an *INSPECTION* or *PLAN REVIEW* or any *OTHER SERVICES* listed on the fee schedule.

**ARTICLE VII.** The cost for the provision of said services shall not exceed the costs reasonably borne by the District.

**ARTICLE VIII.** In the event that fees are not paid at the time of application or upon request for additional fees, the District shall not be obligated to process, approve, or take further action on renewable permits, installation, removal, activity or alteration permits, inspections, plan reviews, or other services necessitating a fee as delineated in the Fire District Fee Schedule.

**ARTICLE IX.** The Board of Directors hereby declares that should any section, paragraph, sentence or word of this ordinance or of the Fire District Fee Schedule referenced herein be declared for any reason to be invalid, it is the intent of the Board that it would have adopted all other portions of this ordinance independent of the elimination there from of any such portion as may be declared invalid.

**ARTICLE X.** The Board of Directors, the Fire Chief or his/her designee shall have the ability to waive any and all fees as adopted by a Resolution of the Board of Directors. When fees are waived, a report shall be provided at the next Board of Directors meeting.

**ARTICLE XI.** The Board of Directors of the Rancho Santa Fe Fire Protection District does hereby approve the adoption of the attached Schedule of Fire District Services and Estimated Fees therefore, (Attachment A, B & C).

# ARTICLE XII. Ordinance 2016-01 is hereby repealed.

#### ARTICLE XIII.

The Secretary to the Board of Directors will certify to the adoption of this Ordinance and cause the same to be published in the manner required by law. This Ordinance will take effect forty-five (45) days after its final passage at a public hearing as required by law.
